1. 2022 NOCCOG Annual Dinner Meeting

2. Budgeting and Accounting Training for Municipalities

Instructor Laird Petrie will provide two-day, comprehensive training on town governments financial requirements and regulations. A collaboration of the Tug Hill Commission and the NYS Association of Towns, the two date session is scheduled for Tuesday and Wednesday, November 29 and 30. 9am - 4pm each day, at the Day One is designed to cover topics that will be beneficial for elected town officials as well as bookkeepers, accountants and comptrollers. Day Two is designed to assist town bookkeepers, accountants and comptrollers to record day to day financial transactions and generate necessary financial reports to the town board and outside agencies. 3. 2021 Visitor Spending Up 164% in Oneida County



Visitor spending in Oneida County totaled \$2.7 billion in 2021, up 164 percent from traveler spending levels in 2019 before the pandemic, according to a recent study released by Empire State Development and New York's I Love NY Division of Travel & Tourism.

Visitor spending across the region covering Oneida, Otsego, Schoharie, Broome, Chenango, Herkimer, Madison, and Montgomery counties totaled \$3.7 billion. Oneida County represented 74 percent of that total and helped support 33,630 jobs. Spending increased 80 percent over 2020 and 142 percent from 2019 pre-pandemic levels. The data in this release comes from the Economic Impact Study of Tourism in New York for 2021 conducted by Tourism Economics.

Visitor spending supported 19,939 people employed directly, indirectly, or induced in travel and tourism jobs in Oneida County and generated \$1.2 billion in household wages, according to the report. Tourism sustains 22.7 percent of all employment in the county. Tourism-generated spending in Oneida County contributed \$134.3 million in state taxes, while local tax revenues totaled \$123.7 million. That resulted in tax savings per household of \$2,846 for county residents in 2021. Tourism Economics, an Oxford Economics Company of Oxford, United Kingdom, with U.S. offices in Wayne, Pennsylvania, conducted the study. The organization studied several sectors of the tourism industry including lodging, recreation, food and beverage, retail and service stations, transportation, and second homes. In Oneida County, all industry sectors remained steady or saw a slight increase in visitor spending. Each industry saw the following spending amounts: lodging, \$1.2 billion; recreation, \$645 million; food and beverage, \$365 million; retail and service, \$460 million; transportation, \$42 million; and second homes, \$31 million.

4. Oneida County Awarded \$2.25 Million Veteran Suicide Prevention Grant

Oneida County has been awarded a \$2.25 million federal grant to help prevent suicide among military veterans.

The funding is issued for three years at \$750,000 per year through the U.S. Department of Veterans Affairs' Staff Sergeant Parker Gordon Fox Suicide Prevention Grant Program (SSG Fox SPGP). The Oneida County has secured the first \$750,000 and then applies for grant renewal the next two years.

The SSG Fox SPGP is a pilot, community-based grant program that will provide financial assistance to eligible entities to provide or coordinate providing suicide prevention services to eligible Veterans and their families.

More than 240 agencies across the country applied for the grant and Oneida County was one of only 80 chosen.

The Oneida County Department of Mental Health will be coordinating the provision of suicide prevention services to eligible local veterans and their families.

The Mental Health Department will be issuing a Request for Proposals in the near future and will be encouraging all eligible organizations to apply. One lead applicant will be chosen to receive this award and will be required to partner with other agencies for this endeavor.
