ATV Recreation: Considerations for Municipalities, January 8 - NEW DATE! -

NOCCOG and the NYS Tug Hill Commission will host an informational session regarding recreational ATV/OHV traffic, on Thursday, January 8th, at 7:00 pm at the Boonville municipal offices.

Join Tug Hill Commission as they present on the factors municipalities should take into consideration when enacting or updating local road laws for ATV use. Now, with over two decades of experience with ATV trails, as well as numerous court cases that shed light on best practices, municipalities are much better positioned to make informed decisions. Taylor will also discuss the detailed approach taken to create a map of the region's ATV trail system, which is based on trail data, local laws, and pertinent court cases.

This basic course addresses the powers and duties of town, village, and city planning boards and commissions. The administrative and regulatory roles of the planning board, including its review of site plans, special use permits, and subdivision plats are discussed, along with the planning board's role in the municipal comprehensive plan. The importance of board procedures, referral to the county planning agency, and making findings are also covered.

This introductory course to the zoning board of appeals focuses on the statutory tests boards must follow to grant use and area variances and proper handling of zoning interpretations. Meeting procedures and notice requirements will also be discussed, along with the ZBA's relationship with enforcement officials and the planning board, and the importance of making good findings.

The responsibilities of the staff of local planning boards and zoning boards of appeals range from accepting applications, to maintaining and archiving records—and everything in between, including issuing notices and transmitting communications on behalf of their boards. This course explores the essential duties of municipal staff to planning boards and zoning boards of appeals, as well as best practices.

Municipal Parks and Recreation Grants Funding

The New York State Office of Parks, Recreation and Historic Preservation (OPRHP) is pleased to announce the second round of the Municipal Parks and Recreation (MPR) Grant Program, awarding up to \$10 million in 2026.



**Parks, Recreation
and Historic Preservation**

MPR funding is available for the construction of recreational facilities and other improvements to municipally owned recreational sites and parks. Examples include playgrounds, courts, playing fields, and facilities for swimming, biking, boating, picnicking, hiking, fishing, camping or other recreational activities. Grants will primarily fund construction costs. Preconstruction activities, such as developing plans and design specifications may be included in the project budget, but MPR cannot fund projects that are solely for planning and design without a construction component. Only one location per application. The MPR grant opportunity can fund up to 90% of the total eligible project costs, with a matching share requirement of 10%. The maximum grant award is \$900,000, and these grants are administered on a reimbursement basis.

Eligible applicants include counties, cities, towns, and villages within New York State that own the property where the proposed project will take place. Applications must be submitted by February 9, 2026, at 4:00 pm.

Volunteer Fire Infrastructure & Response Equipment (V-FIRE) Funding Available

The 2025-2026 Volunteer Fire Infrastructure & Response Equipment Grant Program, better known as the V-FIRE Grant, is accepting applications. This program is a state-funded \$25,000,000 competitive grant program that supports the enhancement of the security and safety of the citizens of New York State by providing critical funding to strengthen volunteer fire departments and districts statewide. Eligible applicants can apply for up to \$1,000,000 if proposing projects for construction, renovation, or purchase costs for critical facilities (buildings, training facilities, etc.) that support fire operations, or up to \$500,000 if proposing projects for allowable fire service equipment to upgrade and improve their response capabilities.

Can the public speak at a public meeting?

The law is silent with respect to public participation (see 22 Opinion of the State Comptroller 311, 1966). And, while *a public body does not have to allow the public to speak, many choose to permit public participation*. In those instances, it has been advised that a public body must treat all people in the same manner. The public body can adopt reasonable rules to ensure fairness. For example, allowing those who want to speak a specific period of time to express their views, but restricting every speaker to the same specific amount of time.

NOCCOG 2025 Review

The NOCCOG Executive Committee feels that it is imperative that municipalities are aware of the efforts and accomplishments of the groups they support. And as our communities look forward to 2026, NOCCOG feels that this is a good time to reflect and report on 2025, with its challenges and accomplishments.

Last year started with a workshop focusing on the best practices for land use, code enforcement, and property tax assessment in Amish communities- an important, and sometimes problematic, topic in many of our municipalities.

In February, a new director was welcomed to the NOCCOG Board, Pam Dibble. Pam is the current town supervisor for the Town of Annsville, and brings not just a fresh perspective, but also years of experience.

This spring, we released, and provided numerous copies of, ***A Reference Guide for Municipal Boards***. This guide is meant to assist all municipal boards, elected and appointed, with certain aspects of meeting protocol, procedures and mandated obligations. The guide covers much of the usual verbiage, definitions, requirements and regulations that are common at municipal meetings. It takes a lot of information from various outlets and puts it in one, convenient and easy to read binder. Copies of which are still available, by request.

We assisted, and helped sponsor, the Tug Hill Commission at this year's Local Government Conference, where we also staffed a NOCCOG information booth. Additionally, NOCCOG covered the cost of one registration for each of our member municipalities. Training and education for our local officials has always been a main focus for our council of government.

The idea to engage students with the efforts of local government continued again this year with the NOCCOG Scholarship Program. Four local students are set to receive a \$500 cash award with the completion of their first college semester this past December. The scholarship program was established to recognize college bound seniors that participate in school or community activities without the desire for reward or recognition. This program is also about bringing awareness on what it takes to keep our local governments functioning.

The GPS Mapping program saw work in Forestport, Boonville, and Annsville. Mike Thompson worked with the towns to map some vital infrastructure locations. Digitally mapped data will help with budgeting, knowledge transfer, emergency situations, grant funding opportunities, and comprehensive plans. The goal of this program is to create a thorough regional map, one that will grow and change as the NOCCOG communities grow and change. We know that getting information to our communities on where NOCCOG and the Tug Hill Commission can assist is always important, so this summer we launched a NOCCOG Service Survey. The results showed that NOCCOG is not just a well-known resource, it also highlighted what is important to our municipalities, and on which issues NOCCOG can focus.

In fact, getting information to our municipalities is always a priority. Each month our advisors share and inform on the many training and funding opportunities available through various organizations and departments. It is the work of the municipal advisors that keeps the connection between our communities and the Tug Hill Commission open.
